1. Balloting before the date of the Sale:

- 1.1 A Registrant must submit the completed and signed Registration of Intent together with cashier's order(s) and a copy of HKID card/Passport and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) of the Registrant (collectively "copy of Company Documents") and a copy of HKID card/Passport of the director(s) to the Sales Office on 16th April 2019 between the hours between 3:00 p.m. and 7:00 p.m. and from 17th April 2019 to 23rd April 2019 (both days inclusive) between the hours between 12:00 noon and 7:00 p.m..

登記人需於 2019 年 4 月 16 日由下午 3 時至晚上 7 時期間及 2019 年 4 月 17 日至 2019 年 4 月 23 日（包括首尾兩日）由中午 12 時至晚上 7 時期間，將已填妥及簽署之「購樓意向登記」連同本票及登記人之香港身份證/護照副本及（如適用）商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事名單副本（統稱「公司文件副本」）及有關董事的香港身份證/護照副本遞交至銷售中心，逾時恕不受理。

- 1.2 The Registration of Intent shall be accompanied with one cashier's order. The amount of each cashier's order shall be HK\$100,000 and made payable to "MAYER BROWN".

- 1.3 The cashier's order will be used as part payment of the preliminary deposit for the purchase of the specified residential property.

- 1.4 Each Registrant shall only be registered under one valid Registration of Intent. Duplicated registration of registrant will not be accepted. The Registration of Intent is personal to the Registrant and shall not be transferable.

- 1.5 The Registration of Intent does not constitute any specific expression of intent to purchase any particular specified residential property or the seeking of any such expression of intent. Any specific expression of intent to purchase a particular specified residential property made in the Registration of Intent will be rejected by the Vendor.

Registrants will not be separately notified of the ballot results.

- 1.8 Every valid Registration of Intent submitted shall be allotted one lot. Each Registrant shall be entitled to purchase one specified residential property which is still available for selection by that Registrant.

- 1.9 The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and/or facilitating smooth operation of the balloting procedures, to adjust the time and date of the balloting. Registrants will not be notified separately of such changes.
