1. Balloting before the First Date of Sale:

- 1.1 A Registrant must submit the completed and signed Registration of Intent together with cashier's order(s) and a copy of HKID card/Passport and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) of the Registrant (collectively "copy of Company Documents") and a copy of HKID card/Passport of the director(s) to the Sales Office on 1st May 2019 between the hours of 12:00 noon and 7:00 p.m. and on 2nd May 2019 between the hours of 12:00 noon and 4:00 p.m..

- 1.2 The Registration of Intent shall be accompanied with one cashier's order. The amount of each cashier's order shall be HK\$100,000 and made payable to "MAYER BROWN".
